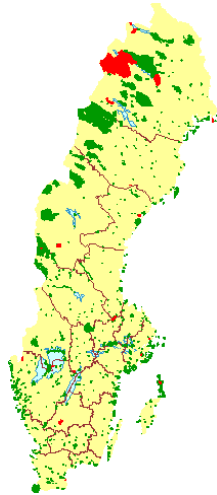
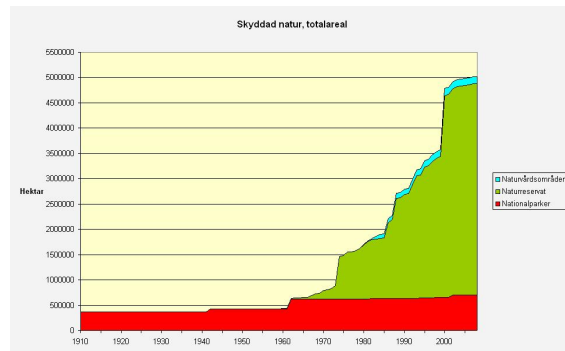


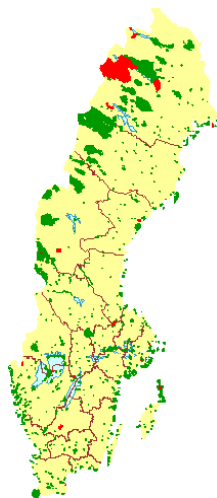
Protected areas in Sweden



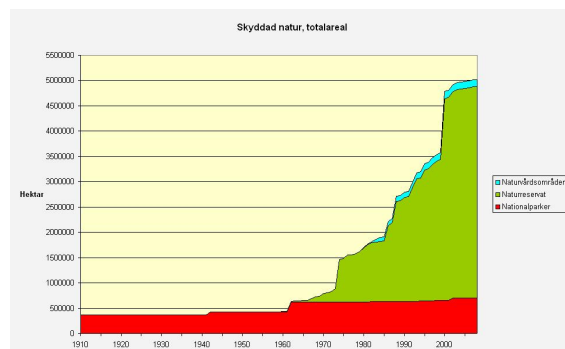
- First National Parks in Europe 1909
- Today approx. 11 % of land area protected
- Primarily nature protection
- Focus on tourism more recently

Does tourism matter to local acceptance of protected areas?

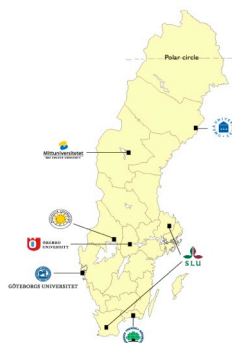

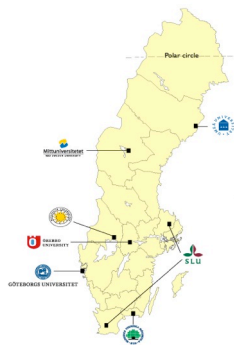


